

"THE SCHEDULE to which the foregoing Scheme or Representation has reference.

"The territory to be annexed to the New Parish of Saint John, Drypool, in the County of York and in the Diocese of York, being:—

"All that portion of the Parish of Drypool, in the said County and Diocese, which is bounded upon the east by the Parish of Marfleet, in the said County and Diocese, upon the south by the said New Parish of Saint John, Drypool, and upon the remaining sides, that is to say, upon the west and upon the north, by an imaginary line commencing upon the boundary which divides the said New Parish of Saint John, Drypool, from the said Parish of Drypool at the junction of Middleburg Street with New Bridge Road, and extending thence northward along the middle of New Bridge Road for a distance of 8 chains or thereabouts to its junction with Rustenburg Street, and extending thence eastward along the middle of Rustenburg Street for a distance of 13 chains or thereabouts to a point in the fence at its eastern end which forms the western boundary of the close numbered 239 upon the Ordnance Survey Map of the County Borough of Kingston-upon-Hull published in the year 1928 on the scale of 25 inches to a mile and also upon the map or plan annexed to this Scheme or Representation and extending thence eastward in a straight line (thereby crossing the said close numbered 239 and the close numbered 240 upon the said maps) for a distance of $15\frac{1}{2}$ chains or thereabouts to a point in the middle of the western end of the ditch forming the northern boundary of the close numbered 242 upon the said maps, and extending thence eastward along the middle of the said ditch for a distance of 8 chains or thereabouts to the point where it turns northward opposite the western end of the fence which divides the close numbered 244A upon the said maps from the close numbered 242 upon the same maps, and extending thence first south-eastward to and then eastward along the last mentioned fence for a distance of $3\frac{1}{2}$ chains or thereabouts to the point where it reaches the western side of Southcoates Lane, and extending thence eastward in a straight line across Southcoates Lane for a distance of 17 yards or thereabouts to the western end of the fence which divides the close numbered 246 upon the said maps from the close numbered 247 upon the same maps, and extending thence first eastward and then in various directions along the fences which divide the said close numbered 246 and the closes numbered 246A, 249 and 293 upon the said maps from the said close numbered 247 and the closes numbered 248 and 294 upon the same maps for a distance of 19 chains or thereabouts to the point where the fence which divides the said close numbered 293 from the said close numbered 294 meets the fence forming the northern boundary of the Withernsea Branch Line of the London and North Eastern Railway, and extending thence first southward to and then eastward along the middle of the said line of railway for a distance of $14\frac{1}{2}$ chains or thereabouts to the boundary which divides the said Parish of Drypool from the said Parish of Marfleet."

And whereas drafts of the said Scheme or Representation have been transmitted to the Patrons and to the Incumbents of the Cures

affected by the arrangements which are contemplated by such Scheme or Representation and such Patrons and Incumbents have respectively signified their assent thereto:

And whereas the said Scheme or Representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme or Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of York.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, duly prepared, and laid before His Majesty in Council, a Scheme bearing date the 17th day of January, 1935, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting a transfer of the ownership of the Advowson or perpetual right of Patronage of and presentation to the Churches and Cure (hereinafter called 'the said Benefice') of Little Blakenham with Nettlestead, in the County of Suffolk and in the Diocese of Saint Edmundsbury and Ipswich:

"Whereas by a conveyance made the 17th day of November, 1934, between Editha Devereux Henderson of The Red House, Little Blakenham, in the said County of Suffolk, Widow, of the one part, and the Right Reverend Walter Godfrey, Bishop of Saint Edmundsbury and Ipswich, of the other part, after reciting that the said Editha Devereux Henderson was seised in fee simple of the Advowson of the said Benefice of Little Blakenham with Nettlestead, it was witnessed that in
