

of the Act has not been complied with, he may, within six weeks after the publication of this notice, make an application for the purpose to the High Court, and if any such application is duly made, the Court, if satisfied that the Order is not within the powers of the Act, or that the interests of the applicant have been substantially prejudiced by any requirements of the Act not having been complied with, may quash the Order either generally or in so far as it affects the applicant.

FURTHER EXTENSION OF FULHAM GENERATING STATION.

NOTICE is hereby given that an application has been made to the Electricity Commissioners by the Council of the Metropolitan Borough of Fulham for the consent of the Commissioners under Section 11 of the Electricity (Supply) Act, 1919, to a further extension of the Council's Generating Station situate in Townmead Road, Fulham, in the county of London, for the purposes of the above mentioned Order and the South East England Electricity Scheme, 1927, on land adjacent thereto, situate between Townmead Road aforesaid and the River Thames, which is owned and was formerly partly occupied by Van den Berghs, Limited.

A plan showing the land in question, together with a plan and an elevation drawing of the Generating Station and particulars of the purpose of the proposed further extension, has been deposited for public inspection at the offices of the London and Home Counties Joint Electricity Authority, 5, Millbank, S.W.1, the London County Council, County Hall, Westminster Bridge, S.E.1, and the Fulham Metropolitan Borough Council, Town Hall, Fulham, S.W.6.

If the London and Home Counties Joint Electricity Authority, the London County Council, or any owner or lessee of property situate within three hundred yards of the proposed further extension wish to state objection to the application, they must do so by registered letter addressed to the Secretary, Electricity Commission, Savoy Court, Strand, W.C.2, within thirty days from the date hereof, and a copy of the objection must be addressed to me.
