Order No. 5310.

FOREIGN HAY AND STRAW (AMENDMENT) ORDER OF 1935.

SUBJECT.

Withdraws, as from the 4th March, 1935, the prohibition of the landing of hay and straw from Finland.

Order No. 5311.

(Dated 27th February, 1935.)

FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1935 (No. 14).

SUBJECT.

Declares the area described in the Schedule to be a Foot-and-Mouth Disease Infected Area

for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925.
