substantially prejudiced by any requirements of the Act not having been complied with, may quash the Order either generally or in so far as it affects the applicant.

2. River Churnet, from its confluence with the River Dove in the Uttoxeter Rural District to Alton Road Bridge in the said Rural District (6 miles).

3. River Derwent, from Cromford Bridge in the Matlock Urban District to Yorkshire Bridge in the Chapel-en-le-Frith Rural Dis-

trict (24 miles).

4. River Dove, from its confluence with the River Churnet in the Uttoxeter Rural District to Okeover Bridge in the said Rural District (9 miles).

- 5. River Idle, from West Retford Bridge in the Borough of East Retford to its confluence with the Rivers Meden, Maun and Poulter in the East Retford Rural District (4.6 miles).
- 6. River Mease, from its confluence with the River Trent in the Lichfield Rural District to its junction with Gilwiskaw Brook near Measham (16 miles).
