

should be made for its union with the Superintendent Registrar's district of Wednesbury and for the re-arrangement of the sub-districts comprised therein;

And whereas it is necessary to transfer the functions under the Registration Acts in relation to the part of the Superintendent Registrar's district of Walsall which is situate without the County Borough of Walsall;

Now, therefore, the Registrar-General of Births, Deaths and Marriages in England in exercise of the powers conferred by Sections 10 and 11 of the Births and Deaths Registration Act, 1837, Section 21 of the Births and Deaths Registration Act, 1874, Section 21 (2) of the Local Government Act, 1929, and of all other powers in that behalf, with the approval and sanction of the Minister of Health, hereby orders as follows:—

1.—(1) This Order may be cited as the Walsall and Staffordshire Registration of Births, etc., Order, 1935, and shall come into operation on the 1st day of April, 1935.

(2) In this Order the term "district" means a Superintendent Registrar's district, and the terms "existing district" and "existing sub-district" mean a district or sub-district which existed immediately before the 1st day of April, 1935.

2. That portion of the existing Walsall district which will on the 1st day of April, 1935, become a separate district situate wholly without the County Borough of Walsall shall be united with the existing Wednesbury district into one district which shall be called the Wednesbury district.

3. That portion of the Urban District of Darlaston included in the existing Walsall sub-district shall be added to and form part of the Darlaston sub-district.

4. The Superintendent Registrar of the existing Wednesbury district shall be the Superintendent Registrar of that district as extended by this Order.

5. The Registrar of the existing Darlaston sub-district shall be the Registrar of that sub-district as altered by this Order.

6. The functions under the Registration Acts in relation to the part of the existing Walsall district which is situate without the County Borough of Walsall are hereby transferred to the Council of the Administrative County of Stafford.

WHEREAS in pursuance of Section 46 (1) of the Road Traffic Act, 1930, as amended by Section 29 of the Road and Rail Traffic Act, 1933, the Isle of Ely County Council have
