

St. John and St. Petrock as they might have had in the Parish Church of Exeter Holy Trinity.

"That all fees ecclesiastical offerings and emoluments which may arise from the said portion so to be separated from Exeter Holy Trinity shall belong to the Incumbent of Exeter St. Mary Major with St. George St. John and St. Petrock.

"That the tithe rentcharge arising from the lands proposed to be separated from Exeter Holy Trinity and annexed to the Parish of Exeter St. Mary Major with St. George St. John and St. Petrock shall remain the property of the Incumbent of Exeter Holy Trinity.

"That no alteration shall be made in the Patronage of the said Benefices or either of them.
