RULES PUBLICATION ACT, 1893.

IN THE MATTER OF THE LONDON TRAFFIC ACT, 1924.

The Minister of Transport hereby gives notice under the Rules Publication Act, 1893, that he proposes after the expiration of at least 40 days from this date in pursuance of the powers conferred upon him by Section 10 of the aforesaid London Traffic Act to make the London Traffic (Prescribed Routes) (No.) (Woodford) Regulations, 1935, in regard to a scheme of "roundabout" traffic working at the junction of the Woodford—Ilford Road (A.1081) with Chigwell Road (A.113) Woodford.

FOOT AND MOUTH DISEASE (INFECTED AREAS) ORDER OF 1935 (No. 22).

SUBJECT.

Contracts the Dorset Foot-and-Mouth Disease Infected Area, as from the 8th May, 1935, to the area as described in the Schedule.
