And whereas by the said Act, it was further enacted that while the said Order remains in force, the abatement (including any abatement therein referred to as an "additional abatement") to be made under the said Order from the amount of the salary to be paid in respect of any office shall be one-half of that which would have been thereby required to be made if subsection (2) of section one of that Act had not been passed:

And whereas it is expedient that the said Order should on and after the first day of July, nineteen hundred and thirty-five, cease to be in force, and that the abatements thereby provided for should accordingly cease and determine:
