ORDER OF THE REGISTRAR-GENERAL IN ENGLAND.

(Dated 17th June, 1935.)

No. 16/1935.

Whereas the city and county borough of Norwich, now co-extensive with the superintendent registrar's district of Norwich, was on the 1st day of April, 1935, by virtue of the provisions of the County of Norfolk Review Order, 1935, extended to include part of the parish of Thorpe (next Norwich) situate in the administrative county of Norfolk and comprised in the superintendent registrar's district of Blofield;

And whereas it is expedient that the city and county borough of Norwich as extended should be wholly comprised within the superintendent registrar's district of Norwich;

Now, therefore, the Registrar-General of Births, Deaths and Marriages in England, in exercise of the powers conferred by Sections 10 and 11 of the Births and Deaths Registration Act, 1837, Section 21 of the Births and Deaths Registration Act, 1874, and of all other powers in that behalf, with the approval and sanction of the Minister of Health, hereby orders as follows:—

1.--(1) This Order may be cited as the Norwich and County of Norfolk Registration of Births, etc., Order, 1935; and shall come into operation on the 1st day of July, 1935. (2) In this Order the term "district" means

(2) In this Order the term "district" means a Superintendent Registrar's district, and the terms "existing district" and "existing subdistrict" mean respectively a district and a sub-district which existed immediately before the 1st day of July, 1935.

2. That portion of the existing Blofield district consisting of part of the parish of Thorpe (next Norwich) which was by virtue of the provisions of the County of Norfolk Review Order, 1935, included on the 1st day of April, 1935, in the county borough of Norwich shall become a separate district, and shall thereupon be united with the existing Norwich district.

3. The area added by Article 2 of this Order to the Norwich district shall cease to be included in the Blofield sub-district and shall be added to and form part of the Norwich South sub-district.
