REGULATIONS FOR THE COMPETITIVE SELECTION OF DISTRICT OFFICERS (MALE) UNDER THE FORESTRY COMMISSIONERS.

N.B.—*These regulations are liable to alteration from time to time. Competitions under these regulations do not take place at fixed intervals, but are held as occasion arises on the occurrence of vacancies.*

1. *Age.*—Candidates must have attained the age of 21 and must not have attained the age of 30 on a date to be fixed in respect of the competition in which they are to take part;
