referred to in Clause 6 of this Scheme, shall be held and accumulated for and towards the endowment of the proposed new Church and District referred to in Clause 7 (b) (2) of this Scheme.

"9. That upon the union taking effect the said Repair Fund shall cease to be applicable for the repair of the said Church of St. Luke, Berwick Street, Westminster, and shall become applicable as part of the said Expenses Fund of the Diocese of London for the repair of the proposed new Church referred to in Clause 7 (b) (2) of this Scheme, and we the said Ecclesiastical Commissioners shall apply to the Charity Commissioners for England and Wales for an Order authorising the transfer of the said sum of £1,065 5s. 4d. £2\ per cent. Consolidated Stock or other the investment or investments then representing the said Repair Fund from the name of 'The said Repair Fund from the name of 'The Official Trustees of Charitable Funds' into the name of us the said Ecclesiastical Commissioners.

"10. That after the said union has taken effect (a) the patronage of the United Benefice shall belong wholly to the Patron of the said Benefice of Westminster, Saint Anne, Soho, and (b) the patronage of the new Church referred to in Clause 7 (b) (2) of this Scheme shall belong wholly to the Rector or Incumbent for the time being of the Rectory of the Parish of Westminster, St. James, Piccadilly, as the Patron of the said Benefice of Westminster, Saint Luke, Berwick Street.

"Provided always that the provisions herein contained relating to the sale and disposal of the Church of Saint Luke, Berwick Street, Westminster, shall not take effect until the consents and approval which by the said Union of Benefices Measure, 1923, are made requisite to the sale under that Measure of the site of any Church shall be obtained to the sale and disposal hereby proposed of the Church of Saint Luke, Berwick Street, Westminster, and the site thereof, together with any ground annexed thereto.

"And provided further that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Measure, or of any other Measure of the National Assembly of the Church of England, or of any Act of Parliament."

And whereas drafts of the said Scheme have been duly published in accordance with the provisions of the said Union of Benefices Measure, 1923, and Notices have been transmitted to the persons or bodies entitled under the same Measure to receive Notice requiring any objections to such draft Scheme to be stated or transmitted in writing to the said Ecclesiastical Commissioners within the time prescribed in the Statutory Rules applicable to proceedings under the said Union of Benefices Measure, 1923:

And whereas the prescribed time has elapsed and no such objections have been so stated or transmitted to the said Ecclesiastical Commissioners:

And whereas public notice of the certification to His Majesty in Council of the said Scheme and the consent thereto in writing of the Bishop of London has been duly given in the manner and within the time prescribed in the Statutory Rules aforesaid:

And whereas the said Scheme has been laid before both Houses of Parliament for the space of two calendar months:

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to affirm the said Scheme and to order that the Benefices therein recommended to be united shall be united to the extent and for the purposes recommended in the said Scheme and further to order and direct that the said Scheme and every part thereof shall be effectual in law immediately from and after the date when this Order shall have been duly published in the London Gazette pursuant to the said Measure.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of London.

HEREAS by an Order in Council, bearing date the 6th day of June, 1935, it was ordered that the Michaelmas Sittings of the Court of Appeal and of the High Court of Justice should in the year 1935 commence on the 7th day of October, and the Long Vacation of the several Courts and Offices of the Supreme Court should for all purposes terminate on the 6th day of October in the same year:

And whereas it is expedient that consequential alterations should be made in the dates for the holding of certain Assizes:

And whereas on account of urgency this Order should come into immediate operation:

Now, therefore, His Majesty, by and with the advice of His Privy Council, is pleased to order, and it is hereby ordered, as follows:—

- 1. The Schedules to the Order in Council dated the 14th day of May, 1912, so far as they relate to the Commission days on the Midland, Oxford, Western and Northern Circuits, shall, with regard to the Autumn Assizes for the year 1935 only, be suspended, and the Schedule to this Order shall pro tanto be substituted therefor.
- 2. This Order shall not affect the existing powers of altering Commission days.
- 3. This Order may be cited as the Autumn Circuit (1935) Order, 1935.
- 4. This Order shall come into operation provisionally in accordance with the provisions of section 2 of the Rules Publication Act, 1893, from the date hereof.
