SERVANTS' REGISTRIES.

THE PUBLIC HEALTH ACTS AMENDMENT ACT,
1907, SECTION 85.

NOTICE is hereby given that by an Order dated the 28th day of August, 1935, made by the Secretary of State, in pursuance of Section 3 of the Public Health Acts Amendment Act, 1907, Section 85 (Registries for Servants) of the said Act, was declared to be in force in the Borough of Jarrow.

The section requires that every person who shall carry on, for the purpose of private gain, the trade or business of keeper of a female domestic servants' registry, shall register his name and place of abode, and also the premises in which such trade or business is carried on, in a book to be kept at the offices of the local authority for the purpose.

Moreover the local authority may make by-laws prescribing the books to be kept and the entries to be made therein, and any other matter which the local authority may deem necessary for the prevention of fraud or immorality in the conduct of such trade or business, and for regulating any premises used for the purposes of or in connection with such trade or business.
