MAIDSTONE FAIRS.
ALTERATION OF DATES.

Whereas a representation has been duly made to me as Secretary of State for the Home Department by the Maidstone Town Council that Fairs have been held at Maidstone on the 13th February, 13th May, 20th June and 17th October in each year and that it would be for the convenience and advantage of the Public that such Fairs should be held in future on the second Friday in February, the second Friday in May, the third Friday in June and the third Friday in October in each year.

And whereas Notice of the said representation and of the time when the same would be taken into consideration has been duly published in pursuance of the Fairs Act, 1873:

And whereas on such representation and consideration it appears to me that it would be for the convenience and advantage of the Public that the said Fairs should in future be held on the second Friday in February, the second Friday in May, the third Friday in June and the third Friday in October in each year:

Now therefore I, in exercise of the powers vested in me by the Fairs Act, 1873, do hereby order that the aforesaid Fairs annually held in the Borough of Maidstone shall in future be held on the second Friday in February, the second Friday in May, the third Friday in June and the third Friday in October in each year.
