via the same route to Hedon Haven and thence eastwards along an unclassified road on the south side of Hedon Haven Basin and thence northwards along road A1033 to Thorn Road Corner, Hedon.

(c) Between Hull and Saltend: via road A1033 to Saltend Lane and thence along Saltend Lane to Saltend Works.

Any objection to the application by any local Authority, the County Council, or any persons who are already providing transport facilities on or in the neighbourhood of any part of the route to which it relates may be made to the Traffic Commissioners (Yorkshire Area), 44, The Headrow, Leeds 1, on or before the Tenth day of October, 1935.
