

The Home Secretary gives notice that in pursuance of Section 2 (1) of the Employment of Women, Young Persons and Children Act, 1920, he has made Orders authorising the employment on two day-shifts:—

(5) Of women over 18 years of age in the circle cutting department at the Mansel Works of Messrs. R. B. Byass & Co. Ltd. (Proprietors—Messrs. Baldwins Ltd.), Port Talbot, subject to compliance with The Tin Plates Welfare Order, 1917, and to conditions as to weekly alternation of shifts, the provision of washing facilities and that transport facilities may be required.
