THE PUBLIC HEALTH ACTS AMENDMENT ACT, 1907.

BY an Order dated seventeenth day of September, 1935, the Minister of Health has declared that on and after the seventh day of October, 1935, the following provisions of the Public Health Acts Amendment Act, 1907, relating to streets and buildings shall be in force in the several Contributory places in the Rural District of Warmley namely, Sections 15, 16, 17 and 27.

The above provisions are declared to be in force subject as regards Section 27 to the conditions specified in the Order.

CHATHAM, ROCHESTER AND DISTRICT ELECTRICITY (AMENDMENT) SPECIAL ORDER.

NOTICE is hereby given that the Kent Electric Power Company whose principal office is situate at 240, High Street, in the City of Rochester (hereinafter called "the Undertakers") intend to apply to the Electricity Commissioners for a Special Order (hereinafter called "the Order") under the Electricity (Supply) Acts 1882 to 1935 for the following purposes (that is to say):—

1. To provide for the suspension of the respective rights of purchase of the Mayor Aldermen and Burgesses of the Borough of Chatham (hereinafter called "the Chatham Corporation") and the Mayor Aldermen and Citizens of the City of Rochester (hereinafter called "the Rochester Corporation") of parts of the undertaking authorised by the Chatham Rochester and District Electric Lighting Order 1890 (hereinafter called "the Principal Order") vested in them respectively under Section 2 of the Electric Lighting Act 1888 until the 14th day of August, 1974.

2. To provide that notwithstanding the suspension of the said statutory rights of purchase of the Corporations under the said Electric Lighting Act 1888 the Chatham Corporation and the Rochester Corporation may within six months after the 14th day of August, 1953, by notice in writing require the Undertakers to sell to the Corporations the said Undertaking on terms of paying the Undertakers the fair market value of the Undertaking as a going concern.

3. To ratify and confirm and make binding upon the parties such of the provisions of an agreement dated ninth day of April, 1935, made between the Chatham Corporation of the first part, the Rochester Corporation of the second part and the Undertakers of the third part as relate to the future prices for the supply of energy within the area of supply defined in the Principal Order and to the laying of distributing mains in the said area.

Printed copies of the draft Order as applied for may be obtained at the office of the under-mentioned Solicitor and at the office of the Undertakers, at 240, High Street, Rochester aforesaid, on payment of 2s. for each copy.

And notice is hereby given that copies of the draft Order have been deposited for public inspection with the Clerk of the Peace for the County of Kent, at his office at Maidstone, and with the Town Clerk, Chatham Corporation, at Chatham, and with the Town Clerk, Rochester Corporation, at Rochester.

Every authority company body or person desirous of bringing before the Electricity Commissioners any objections respecting the application must do so by letter sent by registered post addressed to the Secretary, Electricity Commission, Savoy Court, Strand, London, W.C.2, and despatched on or before the 4th day of November, 1935, and a copy of such objections must at the same time be forwarded to the undermentioned Solicitor.
