Curate in Charge of the Conventional District of Kenton:

"And whereas such yearly sum or stipend will, after the publication in the London Gazette of an Order of Your Majesty in Council ratifying this Scheme, be transferred and secured by an Instrument to be executed by us the said Ecclesiastical Commissioners, under our Common Seal, in accordance with the provisions of the Act of the 29th and 30th years of Her said late Majesty, Chapter 111:

years of Her said late Majesty, Chapter 111: "Now, therefore, with the consent of the Right Honourable and Right Reverend Arthur Foley, Bishop of London (in testimony whereof he has set his hand and Episcopal Seal to this Scheme), we, the said Ecclesiastical Commissioners, humbly recommend and propose that all those portions of the said Parish of Harrow on the Hill, of the said Parish of Harrow Weald, of the said New Parish of Saint John the Baptist, Greenhill, and of the said District Chapelry of Saint Augustine, Wembley Park, which are described in the Schedule hereunder written, all which portions together with the boundaries thereof are delineated and set forth on the map or plan hereunto annexed, shall, upon and from the day upon which any Order of Your Majesty in Council ratifying this Scheme shall be published in the London Gazette, become and be constituted a separate District for spiritual purposes by the name of 'The District of Saint Mary the Virgin, Kenton.'

"And we further recommend and propose that the whole right of patronage of the said proposed District and, when such District shall have become a New Parish, then of such New Parish, and the nomination of the Minister or Incumbent thereof shall, as provided by the said Order in Council bearing date the 15th day of December, 1932, be vested in and exercised by the said Arthur Foley, Bishop of London, and his successors in the same Bishopric for ever.

"And we further recommend that nothing herein contained shall prevent us from recommending or proposing any other measures relating to the matters aforesaid or to any of them in accordance with the provision of the said Acts, or of any of them, or of any other Act of Parliament.

"THE SCHEDULE to which the foregoing Scheme has reference.

"The District of Saint Mary the Virgin, Kenton, comprising:---

"All those contiguous portions of the Parish of Harrow on the Hill, of the Parish of Great Stanmore, of the New Parish (sometime Chapelry District) of Harrow Weald, of the New Parish (sometime District Chapelry) of Saint John the Baptist, Greenhill, and of the District Chapelry of Saint Augustine, Wembley Park, all in the County of Middlesex and in the Diocese of London, which, taken together, are bounded upon all sides by an imaginary line commencing at a point in the centre of the bridge which carries the Harrow and Uxbridge Line of the Metropolitan Railway across the main line of the London Midland and Scottish Railway, and extending thence north-westward along the middle of the said main line of the London Midland and Scottish Railway (thereby crossing the boundary which divides the said Parish of Harrow

on the Hill from the said New Parish of Saint John the Baptist, Greenhill) for a distance of 711 chains or thereabouts to the centre of the bridge which carries it across the footpath leading from Elmgrove Road to Kenmore Avenue, and extending thence north-eastward along the middle of the said footpath (thereby crossing the boundary which divides the said New Parish of Saint John the Baptist, Greenhill, from the said New Parish of Harrow Weald) for a distance of $17\frac{1}{2}$ chains or there-abouts to the point where it reaches the southern end of Kenmore Avenue and thence northward along extending middle of Kenmore Avenue for a distance of 9 chains or thereabouts to its junction with Christchurch Avenue, and extending thence north-eastward along the middle of Christchurch Avenue for a distance of 37 chains or thereabouts to its junction with Kenton Lane and Streatfield Avenue, and extending thence north-eastward along the middle of Streatfield Avenue (thereby crossing the boundary which divides the said New Parish of Harrow Weald from the said Parish of Great Stanmore) for a distance of 60 chains or thereabouts to its junction with Honeypot Lane, and extending thence south-eastward along the middle of Honeypot Lane for a distance of 41 chains or thereabouts to the point where it is crossed by the boundary which divides the said Parish of Great Stanmore from the said Parish of Harrow on the Hill and extending thence first eastward, then south-eastward and then southward along the last mentioned boundary and along the boundary which divides the Parish of Kings-bury, in the said County and Diocese, from the said Parish of Harrow on the Hill (thereby following for the most part the eastern side of Honeypot Lane) for a distance in all of 76 chains or thereabouts to the point near the junction of Honeypot Lane with Kenton Road where the boundaries of the said Parish of Harrow on the Hill, of the said Parish of Kingsbury, and of the said District Chapelry of Saint Augustine, Wembley Park, all meet, and extending thence westward along the middle of Kenton Road, thereby following the boundary which divides the said District Chapelry of Saint Augustine, Wembley Park, from the said Parish of Harrow on the Hill) for a distance of 9 chains or thereabouts to its junction with Preston Road, and extending thence south-westward along the middle of Preston Road for a distance of 65 chains or thereabouts to its junction with Woodcock Hill and extending thence westward along the middle of Woodcock Hill for a distance of 41¹/₂ chains or thereabouts to its junction with Draycott Avenue, and extending thence northwestward along the middle of Draycott Avenue (thereby crossing the boundary which divides the said District Chapelry of Saint Augustine, Wembley Park, from the said Parish of Harrow on the Hill) for a distance of 61 chains or thereabouts to its junction with the roadway leading to Grasmere Avenue, and extending thence south-westward along the middle of the said roadway for a distance of 5 chains or thereabouts to the centre of the bridge which carries the said Harrow and Uxbridge Line of the Metropolitan Railway across such roadway, and extending thence north-westward along the middle of the said line of railway for a distance of 161 chains or
