The KING has been pleased to give and grant unto Gordon Winstanley Spencer, Esq., M.D., M.R.C.S., L.R.C.P., His Majesty's Royal licence and authority to wear the Insignia of the Fourth Class (Civil Division) of the Order of Al Rafidain, which decoration has been conferred upon him by His Majesty the King of Iraq, in recognition of valuable services rendered by him as Chief Ophthalmic Specialist in the Iraq Health Service.

The Home Secretary gives notice that in pursuance of Section 2 (1) of the Employment of Women, Young Persons and Children Act, 1920, he has made Orders authorising the employment on two day-shifts of—

(a) Women and young persons over 16 years of age in the cotton twisting, cop winding, reeling and hand winding departments at the Westbourne Mill of Messrs. Robert Jack & Anderson Ltd., Kilbarchan, Renfrewshire, subject to conditions as to weekly alternation of shifts, accommodation for clothing and facilities for washing and for taking meals.

(b) Women and young persons over 16 years of age in the milk bottle disc department at the works of Messrs. A. Fifer Limited, Buckingham Avenue, Trading Estate, Slough, subject to similar conditions.

(c) Women over 18 years of age in beer bottling and bottle washing at the works of Mr. B. Cunningham, Owen Street, Warrington, subject to similar conditions.

(d) Women and young persons over 16 years of age in the processing of artificial silk at

the Windsor Mill of Messrs. Setacrepes Ltd., Bolton Road, Radcliffe, subject to similar conditions.

(e) Women and young persons over 16 years of age in the paint, plating and galvanizing departments at the National Works of The Co-operative Wholesale Society Ltd., Hall Street, Dudley, subject to similar conditions.

(f) Women and young persons over 16 years of age in folding and pressing hosiery at the works of Messrs. W. Reynolds & Co. (Hucknall) Ltd., Watnall Road, Hucknall, Nottingham, subject to similar conditions.

(g) Women and young persons over 16 years of age in bundling, cutting and washing staple fibre at the works of Messrs. Courtaulds Ltd., Little Heath, Coventry, subject to similar conditions, to the provision of protective clothing, and to a condition that transport facilities may be required.

(h) Women and young persons over 16 years of age in ring spinning at the Newtown Mill of Messrs. John Ashworth (1902) Limited, Lees Street, Pendlebury, Manchester, subject to similar conditions, to the taking of additional humidity readings, and to a condition that transport facilities may be required.
