#### GAS.

THE GAS FUND (CONTRIBUTION) ORDER, 1936, DATED JANUARY 1, 1936, MADE BY THE BOARD OF TRADE UNDER SECTION 7 OF THE GAS REGULATION ACT, 1920 (10 & 11 GEO. 5. C. 28) AS AMENDED BY THE GAS UNDERTAKINGS ACT, 1934 (24 & 25 GEO. 5. C. 28).

In pursuance of the powers conferred upon them by Section 7 of the Gas Regulation Act, 1920, as amended by the Gas Undertakings Act, 1934, and of all other powers enabling them in

that behalf, the Board of Trade hereby prescribe as follows:—

1. The rate of contribution to the Gas Fund for the year 1936 shall be—

(a) one shilling for each five thousand therms in the form of gas sold during the year 1935 (excluding gas sold to other undertakers in bulk for distribution and gas supplied separately for industrial purposes only); and

(b) six pence for each five thousand therms in the form of gas supplied separately for industrial purposes only during the year 1935.

2. Such contribution shall be paid on or before the 1st April, 1936, to the Board of Trade at Great George Street, London, S.W.1, by all Gas Undertakers with respect to whom an Order under the Gas Regulation Act, 1920, shall have been made or to whom subsection (3) of Section 7 of that Act applies by virtue of any public general Act, Special Act or Special Order.

3. Payment of the contribution shall be by cheque made payable to the "Board of Trade" and crossed "Bank of England".

4. This Order may be cited as the Gas Fund (Contribution) Order, 1936.
