(c) In dyeing and finishing tweed at the works of The Lewis and Harris Dyeing and Finishing Co. Ltd., James Street, Stornoway, Isle of Lewis,

(d) In making gas masks at the works of The Dunlop Rubber Co. Ltd., Cambridge Street, Manchester,

subject to conditions as to weekly alternation of shifts, accommodation for clothing and facilities for washing and for taking meals.
