River Ouse (Yorks.) Catchment Board.
Dalton Award.

Notice is hereby given that the Minister of Agriculture and Fisheries has made an Order under the Land Drainage Act, 1930, confirming a scheme submitted to him by the River Ouse (Yorks.) Catchment Board, under Section 8 of the Act, for revoking certain of the provisions of an Award dated 5th December, 1800, made under an Act relating to the Township of Dalton in the Parishes of Rotherham and Thrybergh; and that the Order will become final and have effect as an Act of Parliament, unless within thirty-one days from the date of this Notice a Memorial that the Order shall not become law without confirmation by Parliament is presented to the Minister by some person or body affected by the Order, and having an interest sufficient for the presentation of a Memorial.

LAND DRAINAGE ACT, 1930.

Essex Rivers Catchment Board.

Notice is hereby given that the Minister of Agriculture and Fisheries has made Orders under the Land Drainage Act, 1930, confirming the Orders made by him on the 8th

January last, under Section 11 of the Act, transferring the powers, duties, liabilities, obligations and property of the Chelmer and Blackwater and the Maldon, Wivenhoe and Clacton Internal Drainage Boards to the Essex Rivers Catchment Board; which Orders have now come into force.

Copies of the Orders may be seen at all reasonable hours at the Office of the Clerk of the Catchment Board, Essex Rivers House, Springfield Road, Chelmsford, and also at the Offices of the Ministry of Agriculture and Fisheries, 10, Whitehall Place, London, S.W.1.

By Part III of the Second Schedule to the said Act, it is provided that if any person aggrieved by either of the said Orders desires to question its validity on the ground that it is not within the powers of the Act or that any requirement of the Act has not been complied with, he may, within six weeks after the publication of this notice, make an application for the purpose to the High Court, and if any such application is duly made, the Court, if satisfied that the Order in question is not within the powers of the Act, or that the interests of the applicant have been substantially prejudiced by any requirements of the Act not having been complied with, may quash the Order either generally or in so far as it affects the applicant.

LAND DRAINAGE ACT, 1930.

River Severn Catchment Area.

The Minister of Agriculture and Fisheries hereby gives notice that the River Severn Catchment Board have made application under sub-section (3) of Section 5 of the Land Drainage Act, 1930, that the statutory map of the Catchment Area be varied so far as relates to the extent of the "main river," by adding to the "main river" as shown on the said map the following watercourses:—

(a) *Smestow Brook*, from the point where it ceases to be "main river" up to Aldersley Road Culvert in the Borough of Wolverhampton—a length of 1 mile 1 furlong.

(b) *River Arrow By-pass* formed by the new cut situate on the north side of Oversley Bridge, Alcester, and a short length of the River Alne—a length of 330 yards.

(c) *River Strine* from its confluence with the River Tern at Crudgington up to Wall Road Bridge—a length of approximately 4 miles.

A copy of the statutory map on which the proposed variation is to be made may be inspected at the Office of the Clerk of the Catchment Board, 2, College Yard, Worcester, or at the offices of the Ministry. Any objection to the proposed variation of the statutory map shall be made in writing and sent by post
