Department. No candidate will be eligible for appointment unless he can satisfy the Postmaster-General that he possesses the required local residential qualification and it will be within the Postmaster-General's authority to decline to employ a candidate successful in the examination if he is not satisfied that he complies with this requirement. If there is any doubt an intending candidate is advised to enquire of the Head Postmaster of the town at which the situation is vacant (not the Civil Service Commissioners) whether, in the event of his success in the examination, he would be regarded as eligible for appointment in respect of residence.

7. Candidates must be at least 5 feet in height, and they are expected to attain the height of 5 feet 4 inches before reaching the

age of nineteen years.

8. (i) Persons actually serving in the Army, Navy, or Air Force are ineligible to compete. (ii) Persons holding situations in the Civil Service, Probationary Engineer Cadets in the Navy, and Apprentices in His Majesty's Dockyards must obtain the permission of the authorities of their Department to attend the Examination before the commencement of the competition.

9. Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate education authority has been notified to the Civil Service Commis-

sioners.

10. Application for permission to attend an Examination must be made at such time and in such manner as may be fixed by the Civil Service Commissioners.

11. A fee of 10s. will be required from every Candidate applying for admission to attend an Examination.
