the Universities China Committee in London may contribute for the purposes of the Professor's stipend.

- 5. The Professor shall be subject to the General Regulations of the Statute concerning the Duties of Professors and to those Particular Regulations of the same Statute which are applicable to his Chair.
- 6. Notwithstanding the provisions of Statt. Tit. IV. Sect. 1. § 2 (a). cl. 2, the filling of the vacancy in the Professorship of Chinese which occurred on 14 May 1935 may be suspended by the Hebdomadal Council from time to time provided that it be not suspended after 1 January 1939, on which date this clause shall cease to be operative. During the period of any such suspension the emoluments of such Professorship may, notwithstanding the provisions of Statt. Tit. IV. Sect. 1. § 2 (a). cl. 5, be applied by Congregation for any special purposes connected with the study of Chinese."

STATUTES TO ALTER AND AMEND THE STATUTES IN RELATION TO THE UNIVERSITY OF CAMBRIDGE, MADE UNDER "THE UNIVERSITIES OF OXFORD AND CAMBRIDGE ACT, 1923" (13 & 14 GEORGE V, CHAPTER 33), WHICH AMENDING STATUTES ARE NOW SUBMITTED FOR THE APPROVAL OF HIS MAJESTY THE KING IN COUNCIL.

We, The Chancellor, Masters, and Scholars of the University of Cambridge, in pursuance of the power given to us by the 7th Section of the Universities of Oxford and Cambridge Act, 1923, do hereby alter and amend the Statutes made under that Act in relation to our said University in manner following, that is to say:—

STATUTE A. CHAPTER II.

THE SENATE.

· By amending clause (d) Section 3 so as to read as follows:

(d) Doctors of Philosophy, Masters of Letters, and Masters of Science, if they are University officers, but otherwise not until the end of six years from the beginning of their first term kept by residence, nor until two years have elapsed since their admission to the degree:

Powers of the University.

By substituting the word "Treasurer" for the word "Vice-Chancellor" in Section 8. STATUTE D.

CHAPTER V.

THE PROCTORS.

By rescinding Section 4 and renumbering Section 5—8 as 4—7.

CHAPTER I.

THE OBLIGATIONS OF COLLEGES IN RESPECT OF FELLOWSHIPS,

By inserting before the proviso the following clause:

or (iii) at each College among its Fellows the number competent to hold Professorial Fellowships is not less than its quota of such Fellowships:
