ORDER OF THE REGISTRAR-GENERAL, IN ENGLAND.

(Dated 24th March, 1936.)

Whereas the registration district of Surrey Mid-Eastern is now entirely situate in the Administrative County of Surrey and the registration district of Croydon is now entirely situate in the County Borough of Croydon;

And whereas the boundaries of the Administrative County of Surrey and of the County Borough of Croydon will on the 1st day of April, 1936, by virtue of the provisions of the County of Surrey and County Borough of Croydon (Alteration of Boundaries) Order, 1936, be altered in such a way that the registration districts of Surrey Mid-Eastern and Croydon will no longer be entirely situate in the Administrative County of Surrey and the County Borough of Croydon respectively;

And whereas it is expedient that the aforesaid registration districts should continue to be entirely situate in the Administrative County of Surrey and the County Borough of

Croydon respectively;

Now, therefore, the Registrar-General of Births, Deaths and Marriages in England, in exercise of the powers conferred by Sections 10 and 11 of the Births and Deaths Registration Act, 1837, Section 21 of the Births and Deaths Registration Act, 1874, and of all other powers in that behalf, with the approval and sanction of the Minister of Health, hereby orders as follows:—

1.—(1) This Order may be cited as the Surrey and County Borough of Croydon Registration of Births &c., Order, 1936, and shall come into operation on the 1st day of

April, 1936.

(2) In this Order the term "district" means a Superintendent Registrar's district, and the terms "existing district" and "existing subdistrict" mean respectively a district and a sub-district which existed immediately before

the 1st day of April, 1936.

- 2.—(1) That portion of the existing Surrey Mid-Eastern district consisting of parts of the parishes of Farleigh, Mitcham and Sanderstead which will, by virtue of the County of Surrey and County Borough of Croydon (Alteration of Boundaries) Order, 1936, be included in the County Borough of Croydon shall become a separate district and shall thereupon be united with the existing Croydon district.
- (2) That portion of the existing Croydon district consisting of part of the parish of Croydon which will by virtue of the aforesaid Order be included in the parishes of Mitcham and Sanderstead in the Administrative County of Surrey shall become a separate district and shall thereupon be united with the existing Surrey Mid-Eastern district.
- 3.—(1) That portion of the area added to the Croydon district by Article 2 (1) of this Order which consists of part of the parish of Mitcham shall cease to be included in the Mitcham sub-district and shall be added to and form part of the Croydon North sub-district.
- (2) That portion of the area added to the Croydon district by Article 2 (1) of this Order which consists of parts of the parishes of Farleigh and Sanderstead shall cease to be included in the Beddington and Coulsdon

sub-district and shall be added to and form part of the Croydon South sub-district.

(3) That portion of the area added to the Surrey Mid-Eastern district by Article 2 (2) of this Order which is now included in the Norbury Ward of Croydon County Borough shall cease to be included in the Croydon North sub-district and shall be added to and form part of the Mitcham sub-district.

form part of the Mitcham sub-district.

(4) That portion of the area added to the Surrey Mid-Eastern district by Article 2 (2) of this Order which is now included in the Addington and South Wards of Croydon County Borough shall cease to be included in the Croydon South sub-district and shall be added to and form part of the Beddington and Coulsdon sub-district.

4. The Superintendent Registrars of the existing Surrey Mid-Eastern and Croydon districts shall respectively be the Superintendent Registrars of those districts as

altered by this Order.

5. The Registrars of Births and Deaths of the existing Mitcham, Beddington and Coulsdon, Croydon North and Croydon South sub-districts shall respectively be the Registrars of Births and Deaths of those subdistricts as altered by this Order.
