#### WALCOT HOME FOR GIRLS, BATH.

(Formerly the Industrial School for Girls.)

The Secretary of State for the Home Department hereby gives notice that, being satisfied in view of the addition of new premises at 40, Grosvenor Place, Bath, that there is now accommodation at the Walcot Home for Girls for not more than 70 girls, he has issued a new Certificate increasing from 55 to 70 the number of such girls to be received in the School at any one time, sent thereto in pursuance of the Children and Young Persons Act, 1933, or of any other Act, or otherwise.

The Home Secretary gives notice that in pursuance of Section 2 (1) of the Employment of Women, Young Persons and Children Act, 1920, he has made Orders authorising the employment on two day-shifts of:—

(a) Male young persons over 16 years of age in attending circular knitting machines at the works of Messrs. W. F. Ward & Co., Ltd., Tyrrell Street, Leciester, subject to conditions as to weekly alternation of shifts, accommodation for clothing and facilities for washing and for taking meals.

(b) Women and young persons over 16 years of age in the "Quencher" department at the works of Messrs. Dunn & Co. (Sunderland), Ltd., Burn Park, Sunderland, subject to similar conditions and to a condition that transport facilities may be required.

(c) Women over 18 years of age in weaving printers blankets at the Spring Bank Mills of Messrs. Kershaw & Sons, Ltd., Mossley, subject to conditions similar to those under (b).

(d) Women and young persons over 16 years of age in pickling at the works of The Elba Tinplate Co., Ltd., Crymlyn Burrows, Swansea, subject to conditions as to weekly alternation of shifts and that transport facilities may be required.

(é) Women and young persons over 16 years of age in the cardroom at the B.B. Silk Mills of Messrs. Burnet, Walker & Co., Mill Lane, Cheadle, Cheshire, subject to conditions similar to those under (a) and to the taking of additional humidity readings.

#### COAL MINES ACT, 1930.

MIDLAND (AMALGAMATED) DISTRICT (COAL MINES) SCHEME, 1930.

Whereas in pursuance of Clause 26 of the Midland (Amalgamated) District (Coal Mines) Scheme, 1930, amendments of the said Scheme as set out in the Schedule hereto have been submitted to the Board of Trade by the Executive Board elected under the provisions of the said Scheme:

Now therefore the Board of Trade under the provisions of the said Clause and of subsection (5) of Section 1. of the Coal Mines Act, 1930, hereby approve the said amendments and prescribe the 14th day of April, 1936, as the date from which the said amendments shall come into force.

#### SCHEDULE.

The Midland (Amalgamated) District (Coal Mines) Scheme, 1930 (hereinafter referred to as "the Scheme"), shall be amended in the following manner, that is to say:—

#### First:-

In sub-clause (1) of Clause 15 of the Scheme by deleting the definition of "Special Mine" and substituting therefor the following new definition:—

"Special Mine" means a coal mine which is a completely self-contained coal-producing unit with at least two shafts or adits from the surface which are used solely for the purposes of such unit, from which no coal was raised during the years 1931-1934, and whose circumstances are such as to make it unfair in the opinion of the Standard Tonnage Committee or of the

Executive Board, either to the owners thereof or to other Coalowners in the same Section, that an annual output standard tonnage should be determined therefor.

Secondly:

In Clause 15 of the Scheme by deleting subclause (16) thereof and substituting the following new sub-clause therefor, that is to say:—

Standard Tonnages of Special Mines.

(16) (a) (i) Prior to the commencement of each calendar month the Committee shall determine a monthly output standard tonnage and also a monthly inland supply standard tonnage and a monthly export supply standard tonnage for every Special Mine in respect of such month.

(ii) The Committee shall also determine for each Special Mine concerned a standard tonnage in respect of any distribution of output or supply standard tonnages which may be determined by the Executive Board under the provisions of sub-clause (7) of this Clause

in respect of any class of coal.

(iii) In determining output standard tonnages under this Clause, the Committee shall have regard to the special circumstances of the Special Mine concerned; and in determining supply standard tonnages the Committee shall have regard to the relevant matters.

- (b) Any Coalowner owning a Special Mine who shall be aggrieved by any decision of the Committee under the foregoing provisions of this sub-clause shall have the right to appeal therefrom to the arbitrator appointed under paragraph (h) of this sub-clause and the decision of such arbitrator shall be final and hinding.
- (c) If the Committee at any time decide that an annual output standard tonnage can fairly be determined for any Special Mine, or if at any time a mine ceases to be a Special Mine for any other reason (including any amendments of the Scheme), the Committee shall determine for any such reclassified mine:—
  - (i) An annual output standard tonnage having regard to the special circumstances of such mine;
  - (ii) Inland and export percentages, an output and supply percentage, annual inland and export basic figures and annual inland and export supply standard tonnages, having regard to the relevant matters.
- (d) Within one month of notice of such determination being given by the Secretary to the Coalowner concerned, the Coalowner may refer the determination to re-classify the mine or the determination of standard tonnages therefor under paragraph (c) of this subclause to the arbitrator appointed under paragraph (h) of this sub-clause and the decision of the arbitrator shall be final and binding on all parties.
- (e) (i) After any such re-classification such mine shall for all the purposes of the Scheme be regarded as a Non-Special Mine, and the relevant provisions of this Clause shall thereafter apply to any revision of the respective standard tonnages determined in respect of such mine.

(ii) The provisions of sub-clause (14) of this Clause shall apply (mutatis mutandis) to a Special Mine re-classified as a Non-Special Mine in respect of any intervening period between the date of re-classification and the month of April in the ensuing year.

(f) Any monthly output standard tonnage determined in respect of a Special Mine under this sub-clause shall not form part of the Sectional Tonnage of the Section in which

such Special Mine is situate.

(g) Upon the re-classification of a Special Mine any annual output standard tonnage determined or awarded under this sub-clause shall be added to the then existing Sectional Tonnage of the Section in which such Special Mine is situate:

Provided that if any mine is re-classified by reason of an amendment of the Scheme, the tonnage to be added to the said Sectional Tonnage shall be a tonnage agreed upon by the Coalowners of each Section at a Sectional Meeting, or in default of agreement to be determined by the Special Mine Arbitrator.

(h) All appeals by Coalowners arising out of the provisions of this sub-clause shall be referred to an arbitrator (to be known as "Special Mine Arbitrator") appointed either by unanimous resolution of the Executive Board or, failing such unanimous resolution, by the President of the Incorporated Sheffield Law Society. If the Special Mine Arbitrator so appointed shall not be a qualified Mining Engineer, he shall sit with a qualified Mining Engineer as Assessor, who shall be appointed either by unanimous resolution of Executive Board failing or, unanimous resolution, by the President of the Incorporated Sheffield Law Society.

(i) The Committee shall also determine a monthly coking supply standard tonnage for every Special Mine entitled thereto under the provisions of sub-clause (17) of this Clause.
