REGISTRATION OF SHIPS:—SHIPS' NAMES.

THE MERCHANT SHIPPING (SHIPS' NAMES) AMENDMENT REGULATIONS, 1936, DATED 9TH APRIL, 1936, MADE BY THE BOARD OF TRADE, IN CONJUNCTION WITH THE COMMISSIONERS OF CUSTOMS AND EXCISE, UNDER SECTION 50 OF THE MERCHANT SHIPPING ACT, 1906 (6 EDW. 7. C. 48).

In pursuance of the provisions of Section 50 of the Merchant Shipping Act, 1906 (6 Edw. 7. c. 48) the Board of Trade, in conjunction with the Commissioners of Customs and Excise, hereby make the following Regulations:—

1. The Board of Trade Regulations dated 28th August, 1907 (S.R. & O., 1907, No. 740), as amended by the Merchant Shipping (Ships' Names) Amendment Regulation, 1922 (S.R. & O., 1922, No. 729) shall have effect as if Regulation 2 (b) were omitted therefrom.

2. These Regulations may be cited as the Merchant Shipping (Ships' Names) Amendment Regulations, 1936, and shall come into force on 1st July, 1936.

### TRADE BOARDS ACTS, 1909 AND 1918.

#### ROPE, TWINE AND NET TRADE BOARD (GREAT BRITAIN).

PROPOSAL TO VARY MINIMUM RATES FOR MALE  
AND FEMALE WORKERS.

In accordance with Regulations made by the Minister of Labour under Section 18 of the Trade Boards Act, 1909, and dated 21st April, 1927, the Rope, Twine and Net Trade Board (Great Britain) hereby give notice that they propose to vary minimum rates of wages for male and female workers.

Particulars of the proposed variations may be obtained on application to the Secretary of the Trade Board at the address given below.

In accordance with Section 3 (5) of the Trade Boards Act, 1918, the Trade Board will consider any objections to the above proposal to vary which may be lodged with them within two months from 5th May, 1936. Such objections should be in writing and signed by the person making the same (adding his or her full name and address) and should be sent to the Secretary, Rope, Twine and Net Trade Board (Great Britain), Romney House, Marsham Street, London, S.W.1. It is desirable that objections should state precisely and, so far as possible, with reasons, what is objected to.
