RURAL DISTRICT OF WATFORD.

THE PUBLIC HEALTH ACTS AMENDMENT ACT, 1907.

BY an Order dated the twenty-second day of April, 1936, the Minister of Health has declared that, on and after the eleventh day of May, 1936, the following provisions of the Public Health Acts Amendment Act, 1907, shall be in force in the Rural District of Watford, namely:—

(a) In the several contributory places within the District:—

Sections 15, 23, 25 and 33, comprised in Part II (streets and buildings);

Sections 35, 38, 46, 48 and 49, comprised in Part III (sanitary provisions); and

Sections 52 to 67 (inclusive) comprised in Part IV (infectious diseases);

(b) In the contributory places of Abbots Langley, Aldenham and Watford Rural:—

Sections 39 to 42 (inclusive) comprised in Part III (sanitary provisions).

The above provisions are declared to be in force subject, as regards Sections 23, 25, 35 and 38, to the conditions specified in the Order.
