##### ROAD TRAFFIC ACT, 1934.

Notice is hereby given that the Minister of Transport under and by virtue of the provisions of paragraph (b) of sub-section (4) of Section 1 of the Road Traffic Act, 1934, has made the Road Traffic Act, 1934 (Directions under paragraph (b) of Sub-Section (4) of Section 1) Order, 1936, in respect of certain roads in the London Traffic Area.

The Order provides for the imposition of the speed limit of 30 miles per hour in four lengths of road and for its removal from two lengths of road.

##### *South Lancashire Rivers Catchment Area.*
