The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of His Majesty's Treasury, viz.:—

REGULATIONS RESPECTING OPEN COMPETITIVE EXAMINATIONS FOR THE SITUATIONS OF TYPIST AND CLERK-TYPIST (FEMALE) IN DEPARTMENTS OF THE CIVIL SERVICE.

These Regulations are liable to alteration from time to time.

 The limits of age for this situation are 16½ and 25, provided that the upper age limit may be extended to 28 in the case of candidates who were employed on the 1st July, 1936, and continue to be employed up to the date of the examination in a British Government Department in one of the following capacities, viz. :-Temporary Typist; Temporary Clerk-Typist; Shorthand-Typist; Temporary and-Typist. If an examination Temporary Clerk-Shorthand-Typist. begins in one of the first six months of any year candidates must be of the prescribed age on the 1st day of April in that year. If an examination begins in one of the last six months of any year candidates must be of the prescribed age on the 1st day of October in that year. A candidate who attained the lower limit of age on the governing date would be admitted, but a candidate who attained the upper limit of age on that date would not be admitted. The half year will be reckoned by calendar months.
