UNEMPLOYMENT INSURANCE ACT, 1935.

NOTICE OF PROPOSAL TO MAKE A SPECIAL ORDER VARYING AND AMENDING THE SPECIAL SCHEME OF UNEMPLOYMENT INSURANCE FOR THE INSURANCE INDUSTRY.

The Minister of Labour hereby gives notice that he proposes by virtue of the powers conferred upon him by Section 73 of the Unemployment Insurance Act, 1935, and all powers in that behalf to make a Special Order further varying and amending the Insurance Industry Special Scheme.

Copies of the draft Special Order may be obtained on application in writing to the Assistant Secretary, Ministry of Labour, Unemployment Insurance Department, Montagu House, Whitehall, London, S.W.1.

Objections to the draft Special Order must be sent to the above address within 21 days from the twenty-ninth day of May, 1936.

Every objection must be in writing and must state:—

- (a) the draft Order or portions of the draft Order objected to;
- (b) the specific grounds of objection;
- (c) the omissions, additions or modifications asked for.
