

the said New Parish of Christ Church, Dunston, from the said Parish of Whickham, at the junction of the road called Dunston Bank with the said road leading from Loblely Hill to Whickham, and extending thence north-westward along the middle of the last mentioned road for a distance of 15 chains or thereabouts to a point opposite to the southern end of the fence which divides the close numbered 809 upon the Ordnance Survey Map of the Civil Parish of Whickham published in the year 1919 on the scale of 25 inches to one mile and also upon the map or plan annexed to this Scheme from the close numbered 803 upon the said maps, and extending thence first northward to such fence and then first north-eastward and then in various directions along the fences which divide the said close numbered 809 and the closes numbered 810, 818, 811 and 814 upon the said maps from the said close numbered 803 and the closes numbered 803a, 800 and 799 for a distance in all of 27 chains or thereabouts to the northern end of the fence which divides the said close numbered 814 from the said close numbered 799, and extending thence northward in a straight line for a distance of 10 yards or thereabouts to the south-eastern corner of the close numbered 863 upon the said maps, and extending thence north-eastward along the fence forming the eastern boundary of the last mentioned close for a distance of 9 chains or thereabouts to the point where it reaches the southern side of Market Lane, and extending thence northward in a straight line for a distance of 10 yards or thereabouts to a point in the middle of Market Lane upon the boundary which divides the said Parish of Whickham from the said New Parish of Christ Church, Dunston."

And whereas drafts of the said Scheme have, in accordance with the provisions of the secondly hereinbefore mentioned Act, been transmitted to the Patrons and to the Incumbents of the Cures out of which it is intended that the District recommended in such Scheme to be constituted shall be taken, and such Patrons and Incumbents have respectively signified their assent to such Scheme:

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Durham.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 33rd and 34th years of Her late Majesty

Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, duly prepared, and laid before His Majesty in Council, a Scheme bearing date the 2nd day of April, 1936, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared and now humbly lay before Your Majesty in Council the following Scheme for effecting a transfer of the ownership of the Advowson or perpetual right of Patronage of and presentation to the Church and Cure (hereinafter called 'the said Benefice') of Bedhampton, in the County of Southampton and in the Diocese of Portsmouth:

"Whereas by the Will dated the 18th day of December, 1923, of the late Alice Fanny Sanderson, wife of the Reverend Charles Poyntz Sanderson, of 2 Clarence Parade, Southsea, in the said County of Southampton, Clerk in Holy Orders, the Advowson or perpetual right of Patronage of and presentation to the said Benefice of Bedhampton was devised to the said Charles Poyntz Sanderson for his life and thereafter to the Bishop of Winchester and his successors:

"And whereas the said Alice Fanny Sanderson died on the 12th day of February, 1924:

"And whereas the said Charles Poyntz Sanderson died on the 15th day of December, 1933:

"And whereas Helen Poyntz Sanderson, Spinster, and Agneta Poyntz Sanderson, Spinster, both of The Old Farm House, Havant in the said County of Southampton, are the executors of the Will, dated the 6th day of December, 1933, of the said Charles Poyntz Sanderson, and are the persons in whom, but for the hereinbefore recited devise the said Advowson would now be vested, and they are desirous that the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Bedhampton should be transferred in the manner hereinafter recommended and proposed:

"And whereas at the date of the Will of the said Alice Fanny Sanderson the said Benefice of Bedhampton was situate in the Diocese of Winchester but is now situate in the said Diocese of Portsmouth:

"And whereas the Right Reverend Cyril Forster, now Bishop of Winchester, is desirous that the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Bedhampton, should be transferred to and be vested in the Bishop of Portsmouth for the time being and in token of such his desire he, the said Cyril Forster, Bishop of Winchester, has executed this Scheme as hereinafter mentioned:
