

The urban district of Frome, the parishes of Beckington and Berkley (except so much of those parishes as was added from the parish of Standerwick by an Order of the Local Government Board (No. 16067) dated the 8th day of December, 1883, and made under the Divided Parishes and Poor Law Amendment Act, 1876, as amended and extended by the Poor Law Act, 1879), Nunney Selwood and Wanstrow (except so much of the last-named parish as prior to the 1st day of April, 1933, comprised the parish of Cloford) in the rural district of Frome and so much of the parish of Lullington in the said rural district as prior to the said date comprised the parish of Orchardleigh, all in the county of Somerset.

New Areas.

The parishes of Rode Upton Noble Whatley and Witham Friary in the rural district of Frome so much of the parishes of Beckington Berkley and Wanstrow in the said rural district as is not included in the Frome limits and the parishes of Batcombe Cranmore and Downhead in the rural district of Shepton Mallet all in the county of Somerset.

The parishes of Corsley (except so much thereof as is situate within the limits for the supply of gas by the Warminster Gas and Coke Company Limited) and Horningsham in the rural district of Warminster and Westbury so much of the parish of Southwick in the said rural district of Warminster and Westbury as lies to the south of a line drawn at a uniform distance of two hundred yards north of the centre of the road leading from Woolverton to Southwick and the parish of Maiden Bradley with Yarnfield in the rural district of Mere and Tisbury all in the county of Wilts.

9. To provide that subject to the provisions of the intended Order the Company shall have and may exercise within the added limits or any part or parts thereof all powers, rights and privileges which they have within their existing limits of supply or some part or parts thereof.

10. To authorise the Company to continue maintain and use any mains pipes and works transferred to or vested in them under the intended Order or belonging to them within the added limits and to apply to such mains pipes and works the provisions of the intended Order and of the Acts incorporated therewith and of the Bath Gas Acts and Orders, 1856 to 1932, and of the Bath Gas Order, 1936.

11. To prohibit the British Gas Light Company Limited from exercising in so much of the parish of Southwick in the rural district of Warminster and Westbury as is included in the added limits any of the powers conferred on them in respect of their undertaking under the Trowbridge Gas Orders, 1880 to 1925.

12. To empower the Company to maintain, erect, alter, improve and renew, gasworks with all necessary machinery and apparatus and to make and store gas and to work up and convert residual products upon the lands hereinafter described and to purchase and use material required to work up and convert residual products.

The said lands are:—

The enclosures numbered 310, 311 and 313 in the parish of Frome on the ¹/₂₅₀₀ Ordnance

Map Somerset Sheet XXX. 14 (Edition of 1930).

13. To repeal alter or amend all or some of the provisions of the Frome Gas Act, 1866, the Frome Gas Order, 1884, and the Frome Gas (Charges) Order, 1921, and any other Act or Order relating to the Vendors or their undertaking.

14. To make provisions as to the declaration of the calorific values of and to define the price which may be charged by the Company for gas supplied within the added limits (including provisions empowering the Company to charge different prices for gas supplied by them in different parts of the added limits).

15. To define or fix for the purposes of the intended Order and of the Bath Gas Order, 1932, a basic price or basic prices for the gas to be supplied by the Company within the added limits or any part or parts thereof and to make provision as to the revision of such basic price or prices.

16. To make temporary provision with respect to the ascertainment of the rate of dividend on the consolidated ordinary stock of the Company and as to the period in which gas supplied in the added limits shall be deemed to have been supplied by the Company in case meter indices are read before or after such date or dates as the intended Order may prescribe.

17. To empower the Company to raise additional money by borrowing on mortgage and by the creation and issue of debenture stock or by either of such means.

18. To repeal alter or amend all or some of the provisions of the Bath Gas Acts and Orders, 1856 to 1932, the Bath Gas Order, 1936, and any other Act or Order relating to the Company or their undertaking.

19. To incorporate with the Order with or without modification or to render inapplicable all or some of the provisions of the Lands Clauses Acts the Companies Clauses Consolidation Act, 1845, the Companies Clauses Act, 1863, the Gasworks Clauses Act, 1847, and the Gasworks Clauses Act, 1871.

Any local or other public authority company or person desiring to bring before the Board of Trade any objection to the draft Order may do so by registered letter addressed to the Director of Gas Administration, Board of Trade, Great George Street, London, S.W.1, and despatched on or before the 6th day of July, 1936.

Any such objection shall state:—

- (a) the specific grounds of objection; and
- (b) the omissions, additions or modifications asked for.

A copy of the objection must at the same time be forwarded to the undermentioned Solicitors or Parliamentary Agents.

A copy of the draft Special Order, an Ordnance Map showing the situation of the existing and proposed works of the Company and the boundaries of the existing area of supply and the added limits and an Ordnance Map showing the lands to be used for the manufacture and storage of gas and the manufacture and conversion of residual products have been deposited for public inspection with the Clerk of the Peace for the County of Somerset at his office at Taunton, with the Clerk of the Peace
