Majesty by the said Acts, and of every other power hereunto enabling Him, doth hereby authorize the execution of military manœuvres within the limits specified in the Schedule to this Order during the period of three calendar months commencing from the 15th day of July,

And the Right Honourable Alfred Duff Cooper, one of His Majesty's Principal Secretaries of State, is to give the necessary directions herein accordingly.

SCHEDULE.

All those parts of the Counties of Surrey and Sussex lying within a line drawn as follows, including (except where otherwise mentioned) where any road, or track, is named as a boundary, such road or track:-

On the North, from High Street, Guildford, at the point where it meets the Godalming-Guildford road, eastwards along the road (but excluding it) to Merrow; thence south-eastwards along the road across Albury Downs through Shere to the road junction at Abinger Hammer; thence southwards along the road through Sutton and Holmbury St. Mary, skirting Leith Hill Wood and Etherley Farm to the road junction about half-a-mile north-east of Ockley; thence north-eastwards along the road through Arnolds to the road junction at Beare Green; thence south-eastwards along the road by Palmersbeare Farm through Kingsland to Newdigate; thence southwards along the Newdigate-Rusper road to the point (about 1 mile northwards of Rusper) where the road crosses the Surrey-Sussex county boundary; thence generally eastwards along the county boundary through Copthorne to the point at Felbridge where it crosses the East Grinstead—London road; thence south-eastwards along the road to East Grinstead to the point where the road crosses the railway line about 1 mile east of the railway station; thence generally eastwards along the line of the Southern Railway (but excluding it) through Forest Row and Balls Green to Eridge Station.

On the East, generally southwards from this point along the line of the Southern Railway (but excluding it) through Crowborough, Buxted, Uckfield, Lewes (Station) and Newhaven to Bishopstone Halt; thence due south to the coast.

On the South, from this point westwards along the coast to Felpham (Sea Road).

On the West, along Sea Road, Felpham, to the Felpham Road; thence north-westwards along the road through Upper Bognor and Elbridge into Chichester; thence northwards along the Chichester-Midhurst-Haslemere-Godalming-Guildford road (but excluding it between Chichester and the crossroads about 1 mile northwards of Midhurst), to Guildford (High Street).

Which area surrounded on all sides by a continuous red line is delineated on a map, signed by one of His Majesty's principal Secretaries of State, copies of which are deposited in the War Office and the Privy Council Office.

WHEREAS by Section 2 of the Indian and Colonial Divorce Jurisdiction Act, 1926, it is enacted that His Majesty may, by Order in Council, provide for applying the provisions of Section 1 of the said Act, subject to the necessary modifications, to any part of His Majesty's dominions other than a self-governing dominion (as therein defined) in like manner as they apply to India, and, in particular, such Order in Council may determine the Court by which the jurisdiction conferred by those provisions is to be exercised:

And whereas the Island of Ceylon is a part of His Majesty's dominions other than a selfgoverning dominion as aforesaid:

And whereas it is expedient to provide for applying the aforesaid provisions of the said Act to the Island of Ceylon:

Now, therefore, His Majesty, by virtue and in the exercise of the powers in this behalf by the Indian and Colonial Divorce Jurisdiction Act, 1926, or otherwise in His Majesty vested, is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:-

- 1. This Order in Council may be cited as the Ceylon Divorce Jurisdiction Order in Council,
- 2. On and after the first day of July, 1936, the provisions of the first section of the Indian and Colonial Divorce Jurisdiction Act, 1926, shall apply to the Island of Ceylon in like manner as they apply to India.
- 3. In the application of the said provisions to the said Island-
 - (a) The Court which is to exercise the jurisdiction thereby conferred shall be the Supreme Court of Ceylon, and references in the said first section to a High Court in India shall be read as references to such Supreme Court
 - (b) references in the said first section to India shall be read as references to Ceylon;
 - (c) the reference to the Secretary of State in Council of India in the said section shall be read as referring to the Secretary of State for the Colonies.
