UNIVERSITY OF OXFORD.

STATUTE APPROVED BY CONGREGATION ON TUESDAY, 19 May, 1936.

Whereas it is expedient to amend clauses II and IV of § 4 of Sectio I of Titulus VII of the Statutes of the University of Oxford so as to open the Kennicott Fellowship to graduates of Universities in Great Britain and Northern Ireland and in the Irish Free State, to alter the conditions of standing, and to require successful candidates to reside for two years within the University:

Now the said University in exercise of the powers in that behalf conferred upon it by the Universities of Oxford and Cambridge Act, 1923, and of all other powers enabling it, enacts, subject to the approval of His Majesty

in Council, as follows.

1. In Statt. Tit. VII. Sect. 1. § 4, cl. II (Statuta, ed. 1935, p. 164) strike out from "all members" in l. 11 to "Semitic languages" in l. 19 and substitute: "(a) members of the University of Oxford who have passed all the examinations required for the Degree of B.A. and have obtained a first or second class in a Final Honour School, (b) candidates who have obtained a Degree at some other University in Great Britain and Northern Ireland or in the Irish Free State, such Degree and such University having been approved by the Hebdomadal Council. Preference will be given to candidates who have not exceeded twenty-five years of age."

2. Ibid., 1. 20, after "required" insert: "(a) to submit evidence of his knowledge of Hebrew and the other Semitic languages, unless he has obtained at least a second class in the Final Honour School of Oriental

Studies, and (b) ".

3. Ibid., cl. IV, l. 35, strike out from "either" to the end of the clause and substitute "to reside within the University for two academical years."

TENDERS FOR TREASURY BILLS.

the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London

Banker, Discount House or Broker.

6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday 12 o'clock) on the day on which the relative Bills are to be dated.

7. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief

Cashier's Office, Bank of England.

9. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

FACTORY AND WORKSHOP ACTS, 1901 to 1929.

In pursuance of Section 118 of the Factory and Workshop Act, 1901, the Right Honourable Sir John Simon, one of His Majesty's Principal Secretaries of State, has been pleased to appoint Miss Cicely Hartas Jackson and Kenneth Lesreaulx Sanders, Esq., to be Inspectors of Factories and Workshops.

(c) In the unit assembly sections at the Radio Works of Messrs. Ferranti Ltd., St. Mary's Road, Moston, Manchester, subject to conditions similar to those under (b).
