IN THE MATTER OF THE LONDON TRAFFIC ACT, 1924.

NOTICE is hereby given that the Minister of Transport, in exercise of the powers conferred on him by Section 10 of the aforesaid London Traffic Act, has, by virtue of Section 2 of the Rules Publication Act, 1893, made the London Traffic (Parking Places) (Amendment) Provisional Regulations, 1936, to come into force forthwith as Provisional Regulations and to continue in force until Statutory Rules have been made in accordance with the last-mentioned Act.

These Regulations, which amend the London Traffic (Parking Places) Consolidation Regulations, 1935, provide for the appointment of parking places in Grafton Square, Clapham, Osnaburgh Street and Osnaburgh Terrace, St. Pancras, and the curtailment of the parking place in Evering Road, Hackney.

LAND DRAINAGE ACT, 1930.

River Ouse (Yorks.) Catchment Board.
River Foss Internal Drainage District.

Notice is hereby given that the Minister of Agriculture and Fisheries has made an Order under the Land Drainage Act, 1930, confirming the Order made on the 17th October, 1935, in relation to the Scheme prepared by the River Ouse (Yorks.) Catchment Board, under Section 4 (1) (b) of the Act, making provision for the constitution of the River Foss Internal Drainage District and of a Drainage Board therefor, and matters supplemental thereto.

By Part III of the Second Schedule to the said Act, it is provided that if any person aggrieved by an Order desires to question its validity on the ground that it is not within the powers of the Act or that any requirement of the Act has not been complied with, he may, within six weeks after the publication of this notice, make an application for the purpose to the High Court, and if any such application is duly made, the Court, if satisfied that the Order is not within the powers of the Act or that the interests of the applicant have been substantially prejudiced by any requirements of the Act not having been complied with, may quash the Order either generally or in so far as it affects the applicant.
