Order (hereinafter referred to as "the Order") under and in pursuance of the Gas Undertakings Acts 1920 to 1934, for all or some of the following, amongst other purposes (that is to say):—

- 1. To extend the existing limits for the supply of gas by the Corporation by the addition thereto of so much of the parish of Llanfoist Fawr in the rural district of Abergavenny in the county of Monmouth as is not within those limits (which part of the said parish is hereinafter referred to as "the added limits") and to authorise the Corporation to exercise within the added limits all the powers, rights, privileges and authorities for and in relation to the supply of gas which they have or may exercise from time to time within their said existing limits.
- 2. To confer further powers upon the Corporation in regard to their gas undertaking, and, amongst other things, to empower the Corporation to break up streets outside the limits for the time being of the Corporation for the supply of gas (hereinafter referred to as "the limits of supply") but bounding those limits or streets upon which the limits of supply abut for the purpose of supplying premises abutting upon any such street and being within the said limits; to authorise the Corporation to purchase and use such material as is required to work up and convert any residual products arising directly or indirectly from the manufacture of gas; to secure that fittings let on hire by the Corporation shall continue to be their property and to be removable by them although fixed to premises or to soil thereunder; to make provision for the application of the proceeds from the sale or hire of fittings and for the recovery of sums due in respect of such sale or hire etc.; to enable the Corporation to cut off supplies of gas where charges are not wholly paid; and to authorise the Corporation to require the placing of meters in positions approved by them.
- 3. To empower the Corporation to borrow money for the payment of the costs, charges and expenses of the Order.
- 4. To enable the Corporation to exercise all such powers as may be necessary or convenient for giving effect to the purposes of the Order, and to confer upon them all such other powers as are now usually conferred upon local authorities in connection with the supply of gas.
- 5. To vary or extinguish all rights and privileges which would or might interfere with the objects of the Order and to confer other rights, powers and privileges.
- 6. To incorporate and apply with or without modification all or some of the provisions of the Gasworks Clauses Acts, 1847 and 1871 and the Local Government Act 1933, and the Acts amending those Acts respectively, and to repeal, alter, amend, or re-enact all or any of the provisions of the Abergavenny Improvement Act, 1860, and any other Act or Order relating to the gas undertaking of the Corporation.

Any local or other public authority, company, or person desiring to bring before the Board of Trade any objection to the draft Order may do so by registered letter addressed to the Director of Gas Administration, Board of Trade, Great George Street, London, S.W.1, and despatched on or before the thirty-first day of July, 1936.

Any such objection shall state:-

- (a) the specific grounds of objection; and
- (b) the omissions, additions or modifications asked for.

A copy of the objection must be forwarded to the under-mentioned Town Clark or Parliamentary Agents at the same time as it is sent to the Board of Trade.

Printed copies of the draft Order together with copies of an ordnance map on a scale of not less than one inch to the mile showing the situation of the existing gasworks of the Corporation and the boundaries of the added limits and of the area in which the Corporation are already authorised to supply gas have been deposited for public inspection at the offices of the under-mentioned Town Clerk in the Town Hall, Abergavenny, and with the Clerk of the Peace for the County of Monmouth, at his office at the County Hall, Newport.
