SEA-FISHING INDUSTRY ACT, 1933.

The following Order under Section 2 of the Sea-Fishing Industry Act, 1933, was made on the 9th July, 1936, by the Minister of Agriculture and Fisheries, the Secretary of State for Scotland and the Secretary of State for the Home Department:-

The Sea Fishing Industry (Restriction of Fishing in Northern Waters) Order, 1936.

This Order provides that no person shall during the months of June, July and August in any year, land in the United Kingdom any sea-fish which have been caught in waters situate

- (a) to the northward of a line drawn along the parallel of latitude 71° 10' 10" north from the east coast of Greenland to the North Cape of Norway and to the westward of the meridian of the North Cape of Norway (longitude 25° 47' 20" east); or
- (b) to the northward of the parallel of latitude 64° north and to the eastward of the meridian of the North Cape of Norway (longitude 25° 47′ 20″ east).

This Order came into force on the 9th July, 1936.
