#### RETAIL BESPOKE TAILORING TRADE BOARD (ENGLAND AND WALES).

#### PROPOSALS TO VARY MINIMUM RATES OF WAGES FOR CERTAIN CLASSES OF MALE AND FEMALE WORKERS IN ALL AREAS.

In accordance with Regulations made by the Minister of Labour under Section 18 of the Trade Boards Act, 1909, and dated 21st April, 1927, the Retail Bespoke Tailoring Trade

Board (England and Wales) hereby give notice that they propose to vary minimum rates of wages at present in operation for certain classes of male and female workers in all areas.

Particulars of the proposed variations may be obtained on application to the Secretary of the Trade Board at the address given below.

In accordance with Section 3 (5) of the Trade Boards Act, 1918, the Trade Board will consider any objections to the above proposals to vary which may be lodged with them within two months from the 28th day of July, 1936.
