RULES PUBLICATION ACT, 1893.

LONDON TRAFFIC ACT, 1924.

Notice is hereby given under the Rules Publication Act, 1893, that it is proposed by the Minister of Transport, after the expiry of at least 40 days from this date, in pursuance of

the powers conferred upon him by Section 10 of the aforesaid London Traffic Act, to make "The London Traffic (Waiting, Loading and Unloading of Vehicles and Street Trading) Regulations, 1936":—

(i) governing the waiting, loading and unloading of vehicles; and

(ii) prohibiting the sale of goods from a vehicle except where the goods are delivered to premises in close proximity to the vehicle from which they are sold;
