## LAND DRAINAGE ACT, 1930.

*River Ouse (Yorks.) Catchment Board.  
Earby and Salterforth Internal Drainage Board.*

Notice is hereby given that the Minister of Agriculture and Fisheries has made an Order under the Land Drainage Act, 1930, confirming a scheme submitted to him by the River Ouse (Yorks.) Catchment Board under Section 4 (1) (b) of that Act, making provision for the extension of the period of office of the first members of the Earby and Salterforth Internal Drainage Board until the 1st day of November, 1937; and that the Order will become final and have effect as an Act of Parliament unless within thirty-one days from the date of this Notice a Memorial that the Order shall not become law without confirmation by Parliament is presented to the Minister by some person or body affected by the Order, and having an interest sufficient for the presentation of a Memorial.

A copy of the sealed Order has been deposited, together with a copy of the Scheme, at the Office of the Clerk of the Earby Urban District Council, Council Offices, Earby, Yorks., for public inspection for a period of thirty-one days from the date of this notice, and may be inspected during the ordinary office hours.
