The KING has been pleased to grant unto Christopher Smith Byrom Thompson, of Kirklington Hall in the parish of Kirklington and County of York, Gentleman, Lieutenant the Royal Scots Fusiliers, His Royal Licence and Authority that he, the said Christopher Smith Byrom Thompson and his issue may take and henceforth use the surname of Roysds in addition to and after that of Thompson and that he and they may bear the Arms of Roysds quarterly with those of Thompson, the said Arms being duly exemplified according to the Laws of Arms, and recorded in the College of Arms, otherwise the said Royal Licence and permission to be void and of none effect.

And to command that the said Royal Concession and Declaration be recorded in His Majesty's said College of Arms.
