ROAD TRAFFIC ACT, 1934 (SECTION 1).

SPEED LIMITS IN LONDON TRAFFIC AREA.

Notice is hereby given that the Minister of Transport, under and by virtue of the provisions of paragraph (b) of sub-section (4) of Section 1 of the Road Traffic Act, 1934, has made the Road Traffic Act, 1934 (Directions under paragraph (b) of sub-section (4) of Section 1 (No. 6) Order, 1936, in respect of certain roads in the London Traffic Area.

The Order provides for the removal of the speed limit of 30 miles per hour from specified lengths of roads in Gerrards Cross, Bucking-hamshire; Chipping Ongar and Shenfield, Essex; Edmonton and Southgate, Middlesex; and Cobham, Surrey, and for the imposition of the speed limit in specified lengths of roads in Thorpe, Surrey.
