RURAL DISTRICT OF BRADFIELD.

THE PUBLIC HEALTH ACTS AMENDMENT ACT, 1907.

BY an Order dated the twenty-sixth day of September, 1936, the Minister of Health has declared that, on and after the 19th day of October, 1936, the following provisions of the Public Health Acts Amendment Act, 1907, shall be in force in the contributory places of Basildon, Pangbourne, Purley and Streatley within the Rural District of Bradfield, namely:—

Section 27 (which relates to temporary buildings) comprised in Part II of the said Act.

The above provisions are declared to be in force subject, as regards the said Section 27, to the conditions specified in the Order.

EAST WIGHT GAS.

(Application for Special Order under the Gas Undertakings Acts, 1920 to 1934.)

THE Shanklin and Ventnor Gas Company (hereinafter called "the Company") whose address is Gas Works, Shanklin, Isle of Wight, and the Sandown Gas and Coke Company Limited (hereinafter called "the Sandown Company") whose address is Gas Works, Sandown, Isle of Wight, are applying to the Board of Trade for a Special Order under the Gas Undertakings Acts 1920 to 1934, for the following objects:—

1. To change the name of the Company.

2. To provide for the sale and transfer to and vesting in the Company of the undertaking of the Sandown Company including all lands, hereditaments, easements, works, buildings and other property of whatsoever kind of or belonging to or vested in the Sandown Company except such property or assets (if any) as may be stated in the Order, to prescribe the date on which the said sale transfer and vesting shall take effect, and to make provision with respect to the carrying on of the undertaking of the Sandown Company up to that date.

3. To make provision, in consideration of the said sale transfer and vesting, for the creation and issue to holders of shares of the Sandown Company (hereinafter called "Sandown shares") of stock of the Company (hereinafter called "Shanklin stock") in substitution for Sandown shares and to attach to such Shanklin stock such rights powers and privileges as the Order may provide; to make

provision for the transfer of Shanklin stock into court in the event of the Company being unable to ascertain the persons entitled thereto or to obtain an effectual receipt therefor; and to make provision with respect to the dates up to and from which the Sandown shares and Shanklin stock shall respectively be entitled to, and with respect to the rates and payment of, dividend.

- 4. To provide for the charging upon the undertaking of the Company of redeemable debenture bonds of the Sandown Company and interest thereon and for the order in which those bonds and the interest thereon shall rank.
- 5. To provide for and require the delivery up of the certificates of Sandown shares and the issue instead thereof of certificates of Shanklin stock; to make provision as to the consequences of failure to deliver up certificates of Sandown shares; to authorise and require trustees, executors and other persons to accept, hold and deal with Shanklin stock as they might have held and dealt with Sandown shares; and to provide that references in deeds, wills and other instruments to Sandown shares shall be construed as references to Shanklin stock.
- 6. To make provision with respect to monies due or accruing due to the Sandown Company and the recovery thereof and to make all usual or convenient provisions incidental to the aforesaid sale and transfer and for enabling the same to be carried into effect.
- 7. To provide that some of the directors of the Sandown Company shall become directors of the Company, to make provision with respect to their retirement by rotation, and to vary the number of directors of the Company.
- 8. To make provision with respect to the retirement of and the payment of compensation to the other directors, and the auditors, officers and servants of the Sandown Company, and with respect to the winding up and dissolution of that Company, and to repeal the Sandown Gas Order 1878, the Sandown Gas (Charges) Order 1923 and the Sandown Gas Order 1929 and any other Act or Order relating to the Sandown Company.
- 9. To extend the existing limits of supply of the Company so as to include the limits hereinafter described and hereinafter called "the added limits", to authorise the Company to have and exercise within the added limits such of the powers rights and privileges which they have and may exercise within their existing limits as the Order may provide, and to re-define their limits of supply.

The added limits above referred to are— In the administrative county of the Isle of

So much of the urban district of Sandown-Shanklin as is not within the existing limits of supply of the Company.

In the rural district of the Isle of Wight— The parishes of Brighstone Chale Gat-

combe Niton and Shorwell; So much of the parish of Bembridge as immediately prior to the first day of April nineteen hundred and thirty-three formed

part of the parish of Yaverland;
So much of the parish of Brading as lies within a radius of one mile five furlongs and five chains from the principal entrance to the works of the Sandown Company as existing on the seventeenth day of June
