RURAL DISTRICT OF WORTHING.

BY an Order dated the 26th day of September, 1936, the Minister of Health has declared that, on and after the 19th day of October, 1936, the following provisions of the Public Health Act, 1925, shall be in force in certain contributory places within the Rural District of Worthing, namely:—
