

ROAD TRAFFIC ACT, 1934 (SECTION 1).

SPEED LIMITS IN THE LONDON TRAFFIC AREA.

Notice is hereby given that the Minister of Transport, under and by virtue of the provisions of paragraph (b) of sub-section (4) of Section 1 of the Road Traffic Act, 1934, intends to make the Road Traffic Act, 1934 (Directions under paragraph (b) of sub-section (4) of Section 1 (No.) Order, 1936), the effect of which will be:—

(a) that there will be no speed limit under that Section in respect of the lengths of road specified in the First Schedule hereto; and

(b) that the speed limit under the said Section will apply throughout the length of road specified in the Second Schedule hereto.

FIRST SCHEDULE.

London—Norwich Road (A.11), Harlow, between Station Parade and a point 440 yards north thereof.

Yeading Lane (A.312), between High Road (A.40), Hayes and Ruislip Road (B.455), Northolt.

SECOND SCHEDULE.

London—Norwich Road (A.11), Harlow, between points 440 yards and 880 yards south of Station Parade.
