FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1936 (No. 27).

SUBJECT.

(i) Further contracts as from the 24th November, 1936, the Suffolk Foot-and-Mouth Disease Infected Area to the area as described in the First Schedule.

(ii) Releases the Suffolk Foot-and-Mouth Disease Infected Area from restrictions and revokes Orders Nos. 5435 and 5439 as from the 30th November, 1936.

FIRST SCHEDULE.

*Contracted Infected Area.*

An Area comprising:—

*In the county of East Suffolk.*
