To define the limits of supply of the Company to include—

- (1) The borough of Conway (except (a) so much thereof as prior to the commencement of the Caernarvonshire Review Order 1934 formed part of the Urban District of Llandudno) and (b) so much thereof as is within the limits of Supply of the Mayor Aldermen and Burgesses of the Borough of Colwyn Bay under the Colwyn Bay Gas Order 1927 (S.R. & O. 1927 No. 1046);
- (2) So much of the said urban district of Llandudno as prior to the commencement of the said Review Order formed part of the borough; and
- (3) So much of the parish of Henryd in the rural district of Nant Conway as prior to the commencement of the said Review Order constituted the parish of Llechwedd (hereinafter called "the limits of supply").

and to authorise the Company to exercise within the limits of supply all the powers conferred by the Order.

To enable the Company to lay pipes in streets which bound or abut on the limits of supply for the purpose of supplying gas to premises within the limits of supply.

To define the share capital and borrowing powers of the Company.

To make provision in regard to the profits of the undertaking to be divided amongst the holders of the share capital and to provide for the application of all money raised by the issue of share and loan capital.

To make provision in regard to the calorific value of the gas in the limits of supply of the Company and as to the pressure of such gas.

To enable the Company to purchase lands by agreement, to sell and lease lands to lay pipes in private streets, and for ancillary purposes, to enable the Company to make a specification in regard to the size and material of pipes and fittings to be laid by the owners or occupiers of premises, and to provide dwellinghouses for employees and offices and showrooms.

To make provision in regard to notices for discontinuance of the supply of gas, and in regard to inspection and testing of meters, position of meter, for prevention of improper use of gas, to enable the Company to supply gas fittings, and to provide that such fittings shall not be subject to distress or execution or proceedings in bankruptcy, and though fixed or fastened to the premises shall remain the property of the Company, and to enable the Company to make charges for special reading of meters, and to relieve the Company from obligation to supply in certain cases.

To enable the Company to contract with Stellite Limited for the purchase from or supply of gas in bulk to Stellite Limited.

To make provision in regard to the issue of capital under a profit sharing scheme and for the disposal of shares or stock and deposits of co-partners on death.

To make provision in regard to the authentication and service of notices by the Company, and in regard to the recovery of sums due for fittings, etc.; as to recovery of demands and penalties, and as to several sums in one summons.

To make all such other provisions as may be deemed necessary or expedient for the purposes

of or in connection with or in consequence of the said proposed transfer and vesting.

To incorporate with the Order with or without modifications all or some of the provisions of the Lands Clauses Acts, the Gas Works Clauses Act 1847, and the Gas Works Clauses Act 1871.
