

8. The registrar of any existing sub-district which is extended by this Order shall be the registrar of that sub-district as so extended.

9. The registrars of the existing Anston, Clowne, Shirebrook, Blackwell and Ilkeston sub-districts shall respectively be the registrars of the Anston, Clowne, Shirebrook, Blackwell and Ilkeston sub-districts constituted by this Order.

10. The functions under the Registration Acts in relation to any parish specified in items 1 to 11 in the first column of the Schedule hereto are hereby transferred to the council

of the county or county borough named in the second column of the said Schedule.
