THE PUBLIC HEALTH ACTS AMENDMENT ACT,  
1907.

BY an Order dated the 31st day of December, 1936, the Minister of Health has declared that, on and after the 18th day of January, 1937, the following provisions of the Public Health Acts Amendment Act, 1907, shall be in force in the several contributory places within the Rural District of Langport, namely:—

Sections 23 and 30 (subject to the provisions of section 33) comprised in Part II (streets and buildings); and

Sections 35, 36, 37, 38, 43, 44, 45, 46, 48, 49 and 50 comprised in Part III (sanitary provisions):

The above provisions are declared to be in force subject, as regards sections 23, 30, 35 and 38, to the conditions specified in the Order.
