(b) In the earthen graves now existing in the said Churchyard, in which the remains of Lilius Lee Baker and Jeannie Doris Lavender Baker are interred, the burial may be allowed at their decease of the bodies of Mary Rosalind Pye and Natalie Violet Mary Wakelin, subject to the condition that no part of the coffins containing the bodies shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave.

Now, therefore, His Majesty in Council is pleased hereby to give Notice of such Representation and to order that the same be taken into consideration by a Committee of the Privy Council on the 17th day of March next.

And His Majesty is further pleased to direct that this Order be forthwith published in the London Gazette, and that copies thereof be affixed on the doors of the Churches or Chapels of, or on some conspicuous places within, the Parish affected by such Representation one month before the said 17th day of March.

And whereas it seems fit to His Majesty, by and with the advice of His Privy Council, that the said Orders in Council be further varied:

Now, therefore, His Majesty, by and with the advice aforesaid, is pleased to order, and it is hereby ordered that, notwithstanding anything in the said Orders in Council of the 31st July, 1858, and the 29th May, 1905, it shall be lawful to reinter in the Churchyard of the Parish Church of St. Mary, Blackburn, certain human remains which are about to be removed from a part of the said Churchyard.

Now, therefore, His Majesty, by and with the advice aforesaid, is pleased to order, and it is hereby ordered, that the said Order shall have effect subject to the following exception or qualification, viz.:—

That, notwithstanding anything in the said Order in Council of the 8th day of June, 1854, it shall be lawful to bury, at his decease, the body of the Very Reverend David Herbert Somerset Cranage, Dean of Norwich, in the Cathedral Burial Ground of the City of Norwich, and also in the same grave the body of the wife of the said Dean at her decease.

The KING's Most Excellent Majesty in Council.

WHEREAS the Minister of Health, after giving to the Incumbent and Churchwardens of the Parish of Brackley St. Peter's with St. James', in the County of Northampton, 10 days' previous notice of his intention in that behalf, has, under the provisions of the Burial Act, 1853, as amended by subsequent enactments, made a Representation to His Majesty in Council that for the protection of the Public Health, the opening of any new burial ground in the Borough of Brackley, in the said County of Northampton, save with the previous approval of the Minister of Health, should be prohibited, and that burials should be discontinued forthwith and entirely in the Church of Saint James, in the said Parish, and in the Churchyard attached thereto:
